# HEALTH PROTOCOL FOR 2025 NO RISK AT ALL's season

Only two heats per season and one cover per heat,

no mares will be accepted on foaling heat

The following documents will be required for all mares walking in or boarding:

- Original passport with a **SIRE number** and **French markings**.

# **COMPULSORY VACCINATION PROTOCOL**

Equine Influenza (Flu) and Rhino pneumonia (EHV):

- 1 Primary vaccination, then 1 booster **21** to **60** days later, followed up by a booster **120** 
  - 180 days later, and a booster every 6 months. Marked and stamped in passport.



\*MARES WHOSE VACCINATIONS ARE NOT UP-TO-DATE WILL NOT BE COVERED \*

# **LOW RISK MARES:**

## IN FOAL MARES – MARES WITH FOAL AT FOOT:

- 1 one negative <u>clitoral</u> swab (sinus and fossa) to be taken after the 01/01/25 and within 30 days of foaling, for :
  - METRITIS (Taylorella)
  - KLEBSIELLA
  - PSEUDOMONAS
- 2 a negative **endometrial** swab test to be taken after foaling during heat, for:
  - METRITIS (Taylorella)
  - KLEBSIELLA
  - PSEUDOMONAS
  - a general and complete bacteriology
- **3 EVA -** a negative <u>serological</u> or ELISA result (taken after 01/01/25 **but within 30 days** of the covering )

## **BARREN – MAIDEN MARES :**

- 1. one negative **clitoral** swab test (sinuses and fossa) to be taken after the 01/01/25:
  - METRITIS (Taylorella)
  - KLEBSIELLA
  - PSEUDOMONAS
- 2. a negative **endometrial** swab test to be taken on an unused heat, for:
  - **METRITIS** ( Taylorella )
  - KLEBSIELLA

- PSEUDOMONAS
- <u>a general and complete</u> bacteriology
- 2. **EVA -** a negative <u>serological</u> or ELISA result (taken after 01/01/25 **but within 30 days** of the covering)

#### **EVA**

Taken after 01/01/23 and within 30 days of covering.

- Either 1 negative serological or ELISA result
- Either 2 positive serological results taken 14 days apart, the second one is constant or declining
- Either 1 positive serological result taken in 2024 that is constant or declining compared to the last result from the previous year (both results must be presented)

## **COGGINS**

All mares coming from outside France <u>must</u> be accompanied by a negative Coggins test, taken after 1st January 2025 and within 28 days prior to arrival at Haras de Montaigu.

# **NASAL SWAB**

All racing fillies coming from outside France must have proof of a negative nasal swab for EHV 1,4 taken within 1 month of the first covering.

#### **DOURINE**

Mares arriving from Italy and mares arriving from outside France who have been in Italy since 1st January 2011 will require two negative blood tests for Dourine, the first to be taken within a 28 day period prior to arrival in France, with the second to be taken at the boarding stud, a minimum of 14 days after arrival.

# **HIGH RISK MARES**

**HIGH RISK MARES** - those who have had previous contact with CEMO or **who originate from countries outside France**, **Germany**, **Ireland**, **Italy and the United Kingdom** require:

Before first time of covering:

- **Two** negative clitoral swabs taken at least seven days apart at the home premises or the boarding stud, taken after 01/01/25.
